The Mission

Objectives

- To support the Parties to the Convention on Biological Diversity, the CBD Secretariat, and partners in delivering the goals and targets of the CBD Programme of Work on Protected Areas (PoWPA) related to transboundary conservation, and where consistent with the mission of IUCN and the IUCN World Commission on Protected Areas
- 2. To support implementation of transboundary conservation initiatives through improved **knowledge management, networking and capacity building**.


CBD PoWPA

- Establish new TBPAs and strengthen effective collaborative management of existing TBPAs
- Develop TBPAs in marine areas beyond the limits of national jurisdiction
- Compile and disseminate information on TBPAs
- Provide an enabling policy, institutional and socio-economic environment for TBPAs
- Develop and adopt minimum standards, best practices, and guidelines for establishing TBPAs
- Establish frameworks for monitoring, evaluating and reporting management effectiveness of TBPAs

Transboundary conservation objectives

1. Transboundary protected areas

"A transboundary protected area is an area of land and/or sea that **straddles one or more borders between states**, sub-national units such as provinces and regions, autonomous areas and/or areas beyond the limit of national sovereignty or jurisdiction,

whose constituent parts are especially dedicated to the protection and maintenance of biological diversity, and of natural and associated cultural resources,

and **managed co-operatively** through legal or other effective means."







2. Parks for Peace


"Parks for Peace are transboundary protected areas that are formally dedicated to the protection and maintenance of biological diversity, and of natural and associated cultural resources, and to the **promotion of peace and cooperation**."





3. Transboundary conservation and development area

"Transboundary conservation and development areas are areas of land and/or sea that straddle one or more borders between states, sub-national units such as provinces and regions, autonomous areas and/or areas beyond the limit of national sovereignty or jurisdiction, whose constituent parts form a matrix that contributes to the protection and maintenance of biological diversity, and of natural and associated cultural resources, as well as the promotion of social and economic **development**, and which are managed co-operatively through legal or other effective means."





"Transboundary migratory corridors are areas of land and/or sea in two or more countries, which are **not necessarily contiguous**, but are required **to sustain a biological migratory pathway**, and where co-operative management has been secured through legal or other effective means."

4. Transboundary migratory corridors









Two more types

- a) A **Transboundary World Heritage Site** is where protected areas on either side of an international boundary fall collectively into the designation of the area as a World Heritage Site. *These initiatives are likely to be a small sub-set of TBPAs.*
- b) A **Transboundary Biosphere Reserve** is where areas on either side of an international boundary fall within a Biosphere Reserve. *TBCAs conform most closely to the concept of a Biosphere Reserve, provided they meet UNESCO's designation criteria.*

- Development of a web-based database on transboundary complexes
- Development of TB guidelines/methodology
- Support to knowledge exchange and dissemination
- Stimulate research on transboundary conservation
- Plan activities for the World Conservation Congress 2012 and the World Parks Congress 2014
- Communication and networking



Current activities

- Work on a TB database (incl. contact details of TBPA managers, technical PA data, ecological data, social data, legal frameworks, political situation, etc.)
- Development of a TB guideline for assessing the feasibility of transboundary conservation
- Communication (regular publishing of the TB eNews, information sharing via listserv, upgrading of the TBPA website <u>www.tbpa.net</u>)
- Publishing activities (e.g. European examples of transboundary conservation, TBC guidelines)




Crossing Borders for Nature -European examples of transboundary conservation (in print)

Future and planned activities

- Continued work on the TB database, TBPA website, TB eNews, as well as other communication material
- Development of a TB guideline for World Heritage sites and a monitoring tool for TB conservation areas
- Revision of the Best Practice Guideline on Transboundary Protected Areas
- Establishment of a TBC Global Legal Resource Center
- Intensified work on marine TBPAs guidelines on transboundary marine protected areas
- Communication of results at global events (e.g. WCC, WPC, COP, etc.)



Potential areas of cooperation

- The global transboundary database in particular with regard to European Transboundary Protected Areas
- Expanding the Nature's Design TB process beyond Europe
- Contribution to the revision of the Best Practice Guideline on Transboundary Protected Areas
- Establishment of a TBC Global Legal Resource Center European examples and legal frameworks
- Joint communication activities (TB e News, EUROPARC news, global events, etc.)
